SUBJECT: United States Army Garrison Baden-Wuerttemberg (Heidelberg), Command Policy Memorandum #10C, Environmental Management System (EMS)

1. The United States Army Garrison (USAG) Baden-Wuerttemberg's (Heidelberg) mission is to conduct garrison operations daily within the community, providing installation management programs and services for mission commanders, Soldiers, civilians, and Family members. To sustain this mission, we have achieved a fully implemented ISO 14001-conformant Environmental Management System (EMS), with commitment to:

- a. Continuously improving environmental performance through effective management and planning;
- b. Providing for future generations by fully integrating sustainability into all business processes thereby minimizing resource use and preventing pollution to the maximum extent practicable;
- c. Identifying significant environmental aspects and ensuring they are considered when establishing objectives and targets for our programs;
- d. Complying with relevant environmental legislation and regulations and other requirements to which USAG Baden-Wuerttemberg (Heidelberg) subscribes;
- e. Educating our employees about EMS and their responsibilities to the environment;
- f. Documenting, implementing and maintaining an efficient and effective Management System that is communicated to everyone working for or on behalf of the organization.

2. This Environmental Policy applies to all personnel working for or on the behalf of the USAG Baden-Wuerttemberg (Heidelberg), to include host and tenant units and contractors. They are expected to be sound stewards of the environment and are responsible for understanding and implementing current procedures, practices and policies and by bringing deficiencies of operations to the attention of their supervisors, Environmental Officers or Unit Commanders.
